6.1.1 COVID-19 Update (pg. 1-20)

Superintendent Paula Wyant shared that the Town Hall for Mark Twain is Thursday, July 30th at 6:30pm. The newest guide is available for public schools and guidance on opening school during COVID-19. One of the focal points in this document is that students grades TK through Second Grade are encouraged but not required to wear a mask. Students grades Third through Eighth Grade will be required to wear a mask during school. Students who are unwilling to wear a mask will be attend distance learning until they are willing to wear a mask to school. Two COVID work days for our staff are coming up at the end of the month and the Town Hall meetings for our parents is scheduled for the last week of July. Ms. Wyant expressed her intent of having a full COVID-19 plan at the August Board Meeting. The Town Hall meetings will be held on July 29th at Copper Elementary and 30th at Mark Twain Elementary at 6:30pm outside at each school site. We are collecting questions to be able to answer as many as we can during

these meetings. Ms. Wyant encouraged parents to wear masks to the meeting and to limit the amount of people attending, children should not attend these meetings. The meetings will be on Zoom and recorded for viewing at a later date. The District is also looking into acquiring a You Tube Channel to help with communication.
